CANCELLATION POLICY

- Registration for the event can be canceled without penalty until the registration deadline, i.e. **until October 18th, 2026 (inclusive)** in writing to matchmaking@sario.sk.
- In case the participant cancels the participation in writing to matchmaking@sario.sk **till October 18th 2026, paid registration fee will be returned in full.**
- **In case the participant cancels the participation in writing to matchmaking@sario.sk after October 18th 2026 and lately till October 22nd 2026**, only 40% of paid total amount will be returned due to administration costs to SARIO resulting from registration of the participant. If the registration fee has not been paid by registered participant yet and participant cancels the participation in writing to matchmaking@sario.sk after October 18th 2026 and lately till October 22nd 2026, SARIO has a legal right to the full amount of the registration fee reduced by 40%. This paragraph does not apply to the Business Partner package.
- **In case the participant cancels the participation in writing to matchmaking@sario.sk after October 22nd 2026, the registration fee will not be returned to the participant**, due to inevitable

administrative and organisational costs of the SARIO agency related to registration and matchmaking of the participant for the bilateral negotiations.
